SENATE PRO TEM KEVIN DE LEÓN



ASSEMBLYMEMBER EDUARDO GARCIA

Kevin de León (D-Los Angeles), serves as President pro Tempore of the California State Senate. He is the first Latino elected to the position in over 130 years.

Senator de Leon is focused on building a more prosperous, equitable, and sustainable economy for the Golden State. He's working to make college more accessible and affordable, combat climate change while building the clean energy economy, improve retirement security for low-income workers, and support California's growing diverse communities.

His legislation has created the most ambitious renewable energy goals in the nation, the first-of-its-kind retirement-savings program for low-income workers, and has required a quarter of all cap-and-trade revenue be spent in disadvantaged communities.

He has an extensive record on women's rights, gun-violence prevention, and worker's rights. He has led the fight in the Legislature to combat homelessness and to provide opportunities and protections to our immigrant residents.

Senator de León served four years in the Assembly before being elected to the Senate in 2010. Before the Legislature, he taught citizenship courses to immigrants and led opposition to 1994's anti-immigrant Proposition 187. Senator de León credits his immigrant mother as his inspiration to help build a brighter future for generations to come.

Assemblymember Eduardo Garcia represents California's 56th Assembly District, which includes cities and unincorporated communities in eastern Riverside County and Imperial County. This area has some of the highest unemployment rates in the state even with the presence of large agricultural and tourism industries. Elected in 2014, Assemblymember Garcia is the current chair of the Committee on Water, Parks, and Wildlife. He also serves on the Assembly Committees on Appropriations, Communications and Conveyance, Governmental Organization, and Utilities and Energy. He was named Chair of the Joint Committee on Climate Change Policies and on February 17, 2017 appointed to serve on the California Air Resources Board as an ex-officio member.

In his first term, Assemblymember Garcia was appointed to chair the Assembly Committee on Jobs, Economic Development, and the Economy. As chair, Assemblymember Garcia was responsible for leading the Assembly's review of policies and legislation related to small business development, international trade, and other state and local economic development related issues

to help create a more robust and inclusive economy.

In 2016, Assemblymember Eduardo Garcia passed well over two dozen bills and resolutions signed by Governor Brown. He made a point to champion measures that would increase access to healthcare and recreational opportunities, and bring environmental and economic relief to the areas of the Coachella and Imperial Valley, such as the Salton Sea and New River.



ASSEMBLYMEMBER LORENA GONZALEZ FLETCHER

LISA MANGAT



Assemblywoman Lorena Gonzalez Fletcher was elected in May of 2013, promising to fight for our state's working and middle classes, and she hasn't stopped yet. In 2015, The Atlantic Magazine labeled her "The California Democrat setting the National Agenda" for her practical, progressive legislation aimed at alleviating real issues in people's lives.

In 2014, Lorena authored historic legislation to allow 6.5 million Californians the ability to earn paid sick leave. When AB 1522 was signed by Governor Brown, California became the first state in the nation to guarantee earned sick days for every single private sector worker regardless of employer size or sector. The next year, Lorena brought the idea of Automatic Voter Registration to life for nearly seven million unregistered citizens by authoring and

passing California's New Motor Voter Act. She has passed critical bills to protect the jobs of grocery workers, fight the misclassification of employees as independent contractors, create the first workplace bullying training requirement in the nation, limit excessive CEO compensation in the utility industry, and protect immigrant communities from legal services fraud. Taking on women's equity issues large and small, Lorena co-authored the nation's toughest rules to close the gender pay gap and wrote the legislation that finally forced California to classify high school cheerleading as a sport.

Lorena is the first Latina in California history to Chair the Assembly Appropriations Committee. She is also Chairwoman of the Select Committee on Women in the Workplace.

Lisa Mangat was named Director for the California Department of Parks and Recreation on April 30, 2015 after serving as Acting Director since July 3, 2014. Lisa previously served as the Special Assistant to the Director of State Parks since October 2013. Lisa's broad state government experience will be a benefit as the Department moves forward and continues to work with various partners.

Prior to coming to Parks, Lisa was a Program Budget Manager at the Department of Finance. She also has served as a Senior Fiscal and Policy Analyst at the Legislative Analyst's Office and a Principal Consultant for the California Legislature.

REI is the nation's largest consumer cooperative; providing gear and clothing for active outdoor adventures.

Prior to joining REI, she worked at KPBS where she developed and implemented media and outreach campaigns. During her tenure at KPBS, Myrian helped launch V-me, the nation's largest Spanish language public television network and outreach initiative nationwide.

When she's not working, Myrian is active in her local community. She serves on the California Parks and Recreation Commission as Vice Chair and is also co-creator of the Latina Giving Circle – a collective of women gathering their dollars to support local nonprofits.

Myrian holds a BA in Communications from SDSU. She enjoys hiking, running and traveling with her husband, Giovanni; three year old son, Lucca; and almost one year old daughter, Luciana.
